- The U.S. has a shortage of 7.4 million affordable and available rental homes for Extremely Low Income renter households, resulting in 35 affordable and available units for every 100 Extremely Low Income renter households.
- Seventy-one percent of Extremely Low Income renter households are severely cost-burdened, spending more than half of their income on rent and utilities. These 8.1 million severely cost-burdened households account for 72.6% of all severely.
