### ***Did you know???***

- Thirty-three percent of very low income renter households; 8.2% of low income renter households, and 2.4% of middle income renter households are severely cost-burdened, which means they spend more than 50% of the household income on housing costs.
- Extremely low income (ELI) renter households face a shortage of affordable and available rental homes in every state. In California, there are 21 affordable and available homes for every 100 ELI renter households, and specifically in San Bernardino County that number drops slightly to 19.
