Applicants will be placed in order based on the time the pre-application was received and specified preferences. Once your name is placed on the waiting list you will receive a letter as an acknowledgement of receipt, which should be kept for your records. Changes to your mailing address, family composition, and income must be submitted in writing by either: mailing it to the address listed at the top of page 1; or emailing to AIB@hacsb.com. You will be contacted by mail when your application is pulled from the waiting list.

Criminal Background Policy: The Housing Authority encourages all persons in need of housing assistance to apply to our available housing programs. The Housing Authority will run a criminal background check when your application is processed for eligibility. Each person's criminal record is reviewed for policy compliance, however HACSB makes every effort to provide access to its housing programs. Consideration of circumstances and evidence of good faith efforts to address past criminal history will be taken into account on a case by case basis.

Bloomington Grove, Ivy at College, and Rosena Fountains is subject to low income tax credit income limits which vary per bedroom size. Income eligibility will be discussed when applicants have been selected from the waiting list, and final eligibility will be determined just prior to a household being offered a unit.

2017 Program Income Limits

Reasonable Accommodation: If you or a member of your household have a disability and think you might want or need a reasonable accommodation you may request it at any time.



Notice of Right to Reasonable Accommodation

If you have a disability and as a result of your disability you need . . .

- An exception in the rules/policies or how we do things
- A change or modification in your apartment
- A change or modification to some other part of the buildings or grounds
- A change in the way we communicate with you or give you information

You may ask for this kind of change, which is called a REASONABLE ACCOMMODATION.

If you can show that you have a disability and if your request is reasonable (does not pose “an undue financial or administrative burden”), we will try to make the changes you request.

Your request will be answered within thirty (30) business days unless there is a problem getting the information we need or unless you agree to a longer time. We will let you know if we need more information or verification from you or if we would like to talk to you about other ways to meet your needs.

If your request is turned down, we will explain the reasons and you can give us more information if you think that will help us reconsider our decision.

If you need help filling out a **REASONABLE ACCOMMODATION REQUEST FORM** or if you want to give us your request in some other way, we will also help you.

You can get a **REASONABLE ACCOMMODATION REQUEST FORM** at the Management Office.

NOTICE TO TENANTS

Scammers are using fraudulent websites that could look like Section 8 waiting list lotteries or a database for rental listings. These websites may ask for your financial/credit information or a wire transfer to pay for certain “fees”. Please keep these important tips in mind to protect yourself from scams:

- Contact your local housing authority to find out how to register for the waitlist. There are never any fees to apply, and we do not reach out to you by phone or email for financial information.
- Handle your personal information (such as social security numbers and credit card information) with caution. Do not give them out to websites that are not secure or do not look legitimate.
- When applying for a rental unit, be careful about landlords who ask for deposits/application fees via a wire transfer. Do not give your credit information over the phone, and always try to apply in person or with an actual leasing agent.
