

Application for the waitlist

Thank you for your interest in the HOME Program, we look forward to servicing your housing needs. The HOME Program is an affordable housing program where income limits must be met depending on your household size. This program is monitored by the Housing Authority and the income and rent limits are set by HUD and are as follows for **2013**:

Enclosed you will find the requested application; please complete it to the best of your knowledge and refrain from leaving any unanswered questions. You may return your application to the *Compliance Department* with proof of income to the address or fax number listed above. Be sure to identify which properties you wish to be placed on the list for. Examples of proof of income are 3 current pay stubs, a notice of action, social security or unemployment award letter etc.

Financial: Gross monthly income must meet or exceed (2.0 -2.5) times the monthly rent of the desired apartment size.

General:

- The head of household must be 18 years of age or older, unless he or she is an Emancipated minor.
- All household members including unborn and adopted children will be counted when determining unit size.
- Credit and Criminal background checks will be conducted on all adults
- Proof of income is required; all income sources disclosed on the rental application will be verified thru the appropriate agencies once an apartment has become available.

Waitlist:

- Applicants will be added to a waiting list in chronological order based on the date we have received your application.
- When management receives the next 30-day notice from any current resident, they will notify the applicant's at the top of the waiting list. If that applicant turns down the unit, management will then proceed to the next person on the waiting list.
- If an applicant on the waiting list rejects two units offered to him/her, he/she may remain on the list but will then be assigned a new position on the waiting list based on the date the applicant rejected the second unit.
- **It is the responsibility of the applicant (s) to inform Beacon Property Management if any changes such as address, phone numbers, household size, income etc. have incurred
